ORDER

In exercise of the powers conferred under section 160 of the Delhi Land Reforms Act, 1954 (Act No.8 of 1954), read with rule 168 of the Delhi Land Reforms Rules, 1954, the Administrator of the Union Territory of Delhi hereby directs the Gaon Panchayat of village Chhattarpur to reserve the land of the said village, consisting of the area specified in the table given below, for the works of public utility for purposes of the said Act :-

The Administrator further directs that the Gaon Panchayat while discharging its duties under section 156 of the said Act, shall place the aforesaid land at the disposal of the Development Commissioner, Delhi for the maintenance and development of forests and trees or any other work of public utility for the purposes of the said Act which may be specified by the Administrator from time to time.
