- 3. No candidate without Admit Card (issued by the Department), Photo identity card (Voter ID Card/ Aadhar Card/ Govt. ID/ Driving license) and two passport size photograph shall be allowed to enter the test venue.
- 4. Any kind of malpractices such as impersonation, canvassing, usage of steroids etc. shall invite penal action including rejection from present test as well as debarring from future examinations/tests.
- 5. The candidature to the Physical Standard Test and Walking Test is provisional and subject to the outcome of direction/decision/order, pronouncement of any Court of Law and mere issuance of Admit Card or appearance at the Test does not entitle the candidate to any claim for the post.
- 6. The Department reserves the right to cancel a part of or entire process of test due to administrative reasons and/or in case of unfair means, cheating or other irregularities/malpractices if noticed by the Department.
- 7. The Department reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment/selection.

- 8. Request for postponement of the Physical Standard Test and Walking Test will not be entertained under any circumstances.

(b) Male/Female candidates must pass a Physical Test Covering a distance of 25/16 KMs respectively within four hours on foot.
