4	The Dy. Conservator of Forests (West) reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason therefore.
5	The rates quoted by the tenderer shall remain valid for the period of 06 months from the date of quotation opening date mentioned above, for the subject work and the Department shall not be responsible for payment of any extra on account of escalation of costs during the said period.
