Bidder shall quote the rates against this NIQ on a 'single responsibility' basis ("Rate/Cost of item/work+ GST as applicable") so that the quotation price covers contractor' all obligations and liabilities. The rates and prices quoted by the Bidder shall be inclusive of all Charges/Taxes. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations.
4. The bidder should be from NCR and should be registered with/Trade & Taxes Department, Govt. of NCT of Delhi and should quote their GST Registration No. allotted by the Department of Trade & Taxes, Govt. of NCT of Delhi, and PAN No. allotted by the Income Tax Department, Govt. of India.
5. The Dy. Conservator of Forests (HQ) reserves the right to accept and reject any or cancel any or all the tenders/quotations without assigning any reasons therefore.
6. The rates quoted by the firm/agency shall remain valid for the entire period of current Financial Year i.e. **upto 31.03.2023** for the subject work and the Department shall not be responsible for payment of any extra on account of escalation of costs during the said period.
7. The department shall not be responsible for payment of any compensation on account of

8. The firm/agency abide by the provisions made under the labour laws/GST and other relevant Statutes as applicable in execution of the work and shall be responsible for making good/payment of compensation, if any, to any workman or material during execution of the contract.
