The rates and prices quoted by the Bidder shall be inclusive of all Taxes. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations.
- 4.The bidder should be from NCR and should be registered with /Trade & Taxes department, GNCTD, and should quote their GST Regn no. allotted by Deptt. of Trade & Taxes, GNCTD, and PAN no. allotted by the Income Tax Deptt.
- 5.The Dy. Conservator of Forests (West) reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason therefore.
- 6.The rates quoted by the tenderer shall **remain valid for the period of 06 months from the date of quotation opening date i.e. 01-09-2020 for the subject work** and the Department shall not be responsible for payment of any extra on account of escalation of costs during the said period.
