- 1. The candidates who have been shortlisted on basis of the Computer Based Test (CBT) for the post of Forest Guard in the Department of Forests & Wildlife, Govt. of NCT of Delhi, as per the supplementary list for the post of Forest Guard vide notice no. F.No 1(11)/DCF(HQ)/Estt./Rect.-EdCIL/2020/5688-95 dated 2.8.2022 are now required to appear for Physical Standard Test and Physical Endurance Test.
- 2. The Physical Standard Test, Physical Endurance Test, Biometric Verification and Document Verification for the post of Forest Guard is to be held on 08.08.2022 at National Zoological Park (Delhi Zoo), Mathura Road, New Delhi-110003 at 04:00 AM.
- 3. No candidate without Admit Card (issued by the Department), shall be allowed to enter the test venue. Candidates Must come with Original Copy and self-attested photocopy of the following documents for Document Verification:
 - a. System generated printout of application with candidates' scanned photograph & signature and Admit Card of CBT.
 - b. Proof of application fee receipt.
 - c. Certificate/Marks-sheet of Secondary School Exam in which date of birth of the candidate is indicated.
 - d. Degrees & Certificates of all educational and professional/higher qualification, along with marks-sheet of all years/semesters, if any.
 - e. Certificate/proof of SC/ST/OBC/OBC(NCL)/Ex-servicemen/EWS etc., as the case may be, issued by the concerned Competent Authority.(if applicable)
 - f. Candidates already employed with Govt. Departments/PSU/Autonomous Bodies will have to produce 'No

- Objection Certificate(NOC)' from the employer at the time of Joining Service, if offered appointment.
- g. Aadhar Card, if not issued then registration slip for Aadhar.
- h. Identity proof such as Voter ID Card, Passport, Driving License etc.
- i. All other documents, as per details given in the advertisement and/or call letter.
- j. Four Passport size photographs.
- 4. Any kind of malpractice such as impersonation, canvassing, usage of steroids etc. shall invite penal action including rejection from present test as well as debarring from future examinations/tests.

- 7. The Department reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment/selection.
- 8. Request for postponement of the Physical Standard Test and Physical Endurance Test will not be entertained under any circumstances.
- 9. Any dispute with regard to this recruitment will be subject to courts/tribunals having jurisdiction over Delhi.
- 10. No TA/DA is admissible to any candidate for appearing in the test.
- 11. All the candidates are strictly advised to wear vest/T-Shirt for affixing chest badge for clear identification during Physical Standard Test and Physical Endurance Test.
- 12. Candidates should scrupulously follow the above instructions and also that of the designated officers of the Department at the Test Centre failing which the candidature of the candidate shall be cancelled.

- 14. The details of Physical Standard Test and Physical Endurance Test requirements are presented below:
- (a) The minimum standards for height and chest girth for a candidate shall be as follows:

- (b) Male/Female candidates must pass a Physical Endurance Test Covering a distance of 25/16 KMs respectively within four hours on foot.
- 15. Candidates, those who qualify in the Physical Standard Test and Physical Endurance Test shall be called for Document Verification, immediately after the completion of PET/PST.
- 16. In case, a candidate does not appear for verification of documents/identity along with original documents, he/she shall not be eligible for appointment and his/her candidature shall be rejected. No Second opportunity shall be provided for verification of documents/identity in any case.
