4. The bidder should be from NCR and should be registered with/Trade & Taxes Department, Govt. of NCT of Delhi and should quote their GST Registration No, allotted by the Department of Trade & Taxes, Govt. of NCT of Delhi, and PAN

No. allotted by the Income Tax Department, Govt. of India.
