TERMS & CONDITIONS OF THE E- TENDER

1. E- Tender invited for the work of “E-TENDER FOR SUPPLY AND CREATION OF 8282 NUMBERS OF BAMBOO PLANTATION (BAMBUSETUM) AT GALIBPUR VILLAGE AREA UNDER WEST FOREST DIVISION” Department of Forest and Wildlife, GNCTD, West Forest Division, Mandir Lane, New Delhi -110060, through e- tendering. The successful tenderer/bidder shall be required to execute the work as specified in the Tender Application Form within 10 days' time from the date of communication of the approval of the Competent Authority.
2. As per market rate including loading unloading and transportation charges estimated cost is **Rs. 2,21,44,015/- (Rupees Two Crores Twenty One Lakhs Forty Four Thousands and Fifteen Only)**.
3. Participation in the online bid shall amount to bidder's acceptance of the terms and conditions of the tender.

The bidder shall submit on or before the date given in the Notice Inviting e-Tender, the Technical Bid and the Financial Bid online in the prescribed format given in e-Tenderingsite.

4. The Technical Bid should consist of the following documents:-

a.	Bid Security/Earnest Money Deposit, for an amount of Rs. 11,07,201/- (Rupees Eleven Lakhs Seven Thousand Two Hundred and One Only) i.e.,5% of Estimated cost Rs. 2,21,44,015/- in the form of an Account Payee Demand Draft/ FDR from any commercial Bank in favour of DDO, DCF (West), payable at Delhi. The EMD in original shall be submitted in the Office of DCF (West) Dairy & Dispatch Counter on or before the closing date and time mentioned on the e procurement portal.
b.	Scanned copy of registration /Association with Government/Autonomous Bodies for Horticulture/Forestry works.
c.	<u>Experience</u> 1. Self-attested scanned copy of experience of having successfully completed supply of trees species or undertaking similar nature of work in the past in any state in India. 2. The bidder must have the experience of developing at least two bambusetums in India.
d.	<u>Turnover</u> Self-attested scanned copy of the last three years, ending 31 st March of the previous financial year should be at least 30% of the estimated (gross) value of the work (duly audited by Chartered Accountant) on annual basis. If any particular tenderer has achieved this yearly turnover up to the date of receipt of application in the finished part of the ongoing financial year, the same also be taken into account to meet the requirement. This is to be certified by the Chartered Accountant quoting his membership number and date upto which his certificate of practice is valid.
e.	<u>Solvency</u> Self-attested scanned copy of financial solvency of 10% of the cost of the work as shown in the tender documents issued by any Commercial Bank and the Average annual financial turnover (gross) of similar nature of work
f.	Self-attested copy of PAN Card under Income Tax Act along with last three Years income tax returns filed with Income Tax Deptt.,
g.	Self-attested copies of GST registration number.
h.	An undertaking to the effect that the contractor/agency has not been blacklisted by any Govt. Department in earlier occasions.
i.	Scanned copy of signed terms and condition by contractor.

Tenderer/Bidder must submit copies of all documents required through online

5. Tenderer/Bidder shall quote the rates in the prescribed form for Price Bid given in E- Tendering site against this tender on a 'single responsibility' basis such that the Tender price covers contractor's all obligations and liabilities in compliance to act/rules of the land. The rates and prices quoted by the Bidder shall be inclusive of all Taxes.
6. The tenderer/Bidder is expected to examine all instructions, Forms, Terms and Conditions in the Tender document before participation in this e-tender. The validity of tender will be 01 year for award after approval.

7. In case the tenderer/Bidder has any doubt about the meaning of anything contained in the tender document, he shall seek clarification from the office of the DCF(WEST), Mandir Lane, New Delhi-110060.
8. The successful tenderer/bidder shall execute an agreement with (DCF WEST) soon after deposit of 5% of the tendered value as Performance Guarantee within 10 days w.e.f. the date of acceptance of the offer in the form of Demand Draft/Fixed Deposit Receipt having a validity of 06 months w.e.f. the date of acceptance of the offer, drawn on any of the Commercial Banks payable at Delhi, in favour of **D.C.F. (WEST), payable at Delhi**.
9. The authorized representatives/Purchase Committee of this office/ Department will open the Technical Bid in the presence of the Tenderer/Bidders or their representatives who choose to attend at the appointed place and time. The Qualification for the technical bid shall be based on the online receipt of all the documents required & listed above clause in (4) & (5) on or before the closing date and time of bidding mentioned on the e procurement portal.
10. Financial Bids/Price Bids of only the technically qualified bidders will be opened for evaluation in the presence of qualified bidders who choose to be present at the time of opening of Financial Bids.
11. Rates shall be compared on the basis of total cost for all the items taken together for approved Technical bid.
12. The Offers of tenders not accompanied by documentary proof or do not meet the eligibility criteria as mentioned above shall not be considered. Canvassing or negotiation, direct or indirect, would render the tender liable for exclusion from consideration.
13. The Dy. Conservator of Forests (West Division) reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason thereof.
14. The Department of Forests & Wildlife, Govt. of N.C.T. of Delhi, is not bound to accept the lowest rate/cost or any bid and may at any time by notice in writing to the bidder(s) terminate the tendering process.
15. Department of Forests & Wildlife, Govt. of N.C.T. of Delhi, is at liberty to accept rates quoted for one item and reject other or may accept gross value of complete tender on the recommendation of Committee existing for the purpose.
16. The Department of Forests & Wildlife, Govt. of N.C.T. of Delhi, may terminate the work order if it is found that the contractor is black listed on the previous occasions by any of the Government Departments/Institutions/Local Bodies/Municipalities/Public Sector Undertakings etc.
17. The successful Tenderer/Bidder shall ensure full compliance with Tax laws of India with regard to the work order(s) and shall be solely responsible for the same.
18. The successful bidder will comply all the rules & regulations of the land with latest circular/orders issued by various Government Departments applicable to the work and bidder will be solely responsible.
19. Failure of the successful tenderer/bidder to comply with the requirements of above clauses shall constitute sufficient grounds for the annulment of the work order and forfeiture of Bid Security/Performance Security.
20. The Quantity of supply of items may increase or decrease as per actual requirement. The successful bidder will have to supply the above mentioned quantity of plants and as per supply order issued by this office/department.
21. Duly completed books of accounts/documents should be produced as and when required by the department.
22. The rates quoted by the tenderer shall remain valid for one year from the date of opening of Financial Bid and the Department shall not be responsible for payment of any extra payment on account of escalation of costs during the said period.
23. The payment will be released to the successful tender/bidder after award of work order following agreement for the supply of plants by the Department on completion of satisfactory supply of plants as detailed in BOQ, supply order wise, on verification of the actual supply executed by the tenderer, by DCF (West) after deducting Income Tax or any other Tax or duties as liable as per the prevailing Act/Rules and the instructions/guidelines issued by the Government/Departments from time to time.

24. In the event of non-execution of the work, the Security Deposit shall be forfeited with the Government and the balance work, if any, shall be got executed at the risk and cost of the tenderer by rescinding the contract for the reasons to be recorded by DCF (WEST) in writing.
25. The department shall not be responsible for payment of any compensation on account of any loss caused to the tenderer due to natural calamities or other supervening impossibilities.
26. The contractor shall not construct any permanent structure at the site of work and shall have no right on the land or asset of the Government.
27. In no circumstances, the contractor would be allowed to sublet the works in part or whole of the contract, assigned to them.
28. Any dispute or difference arising out of this contract will be resolved through joint discussion of the authorized representatives of the concerned parties. However, if the disputes are not resolved by the joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by the HOD, Department of Forests & Wildlife, GNCTD.
29. The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceedings shall be governed by the Indian Arbitration and Conciliation Act, 1996 as amended from time to time.
30. The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the dispute relates on account of the arbitration and payment to the contractor shall continue to be made in the terms of the contract. Arbitration proceedings will be held at Delhi/New Delhi only.
31. All disputes arising out of the execution of the agreement shall be subject to the jurisdiction of the Court at Delhi only.
