Notice inviting quotations (NIQ) is hereby issued for inviting quotations from the registered firms/dealer/supplier for **supply of boneless chicken meat.** The details are as under:

The quotation and document should be sent in sealed cover in favour of the Department of Forests and Wildlife, Govt. of NCT of Delhi.

The quotation should reach in this office latest by 2:00 p.m. on a before dated **13.01.2026**(next working day in case of Government holiday) and the same will be open on the same day at 2:30 p.m. by the purchase committee. The rate should be quoted and GST should be indicated separately as per the prevailing GST laws .Quotations received after stipulated date and time will not be accepted / entertained and summarily will be rejected. In case of any dispute, the decision of the CF (HQ), Dept. Department of Forests and Wildlife, Govt. of NCT of Delhi, A-Block, 2nd Floor, Vikas Bhawan, IP Estate, New Delhi- 110002, should be final and binding.

TERMS AND CONDITIONS OF THE NIQ

- Submission of quotation shall amount to bidder's acceptance of the terms and conditions of the tender by the bidder
- Mode of payment would be subject to satisfactory completion of work / supply and its verification.
- Bidder shall quote the rates against this NIQ on a 'single responsibility' basis ('Rate/Cost of item/work+ GST as applicable') so that the quotation price covers contractors' all obligations and liabilities. The rates and prices quoted by the Bidder shall be inclusive of all Charges/Taxes. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations.
- The Bidder should be from NCR and should be registered with Trade and Taxes Department, Government of NCT of Delhi and should quote their GST registration number allotted by

the Trade and Taxes Department, Government of NCT of Delhi, and PAN number allotted by the Income Tax Department, Government of India. Copy of the same to be attached with the submitted quotation by the bidder.

- The Conservator of Forests (HQ) reserves the right to accept and reject any or cancel any or all the tenders/quotations without assigning any reason therefore.
- The rates quoted by the firm/agency shall remain valid for the entire period of the current Financial Year i.e. up to 31.03.2026 for the subject work and the Department shall not be responsible for payment of any extra on account escalation of cost during the said period.
- That department shall not be responsible for payment of any compensation on account of any loss caused to the bidder/tender/quotation due to natural calamities or other supervening impossibilities.
- The firm/agency shall abide by the provisions made under the Labour laws/GST and other relevant Statutes as applicable in execution of the work and shall be responsible for making good/payment of compensation, if any, to any workman or material during execution of the contract.
- In case of any dispute arising out of the execution of the term and conditions of this short term quotation or part thereof, the decision of the CF (HQ), Govt. of NCT of Delhi shall be final and binding on both the parties. In the event of the disputes still remaining unresolved, the appeal shall rest with the PCCF/HOD, Dept. Department of Forests and Wildlife, Govt. of NCT of Delhi, whose decision shall be final and binding on both the parties.

- All disputes arising out of the execution of the agreement shall be subject to the jurisdiction of the Court of Delhi.
