ELIGIBILITY CRITERIA & SCOPE OF SERVICES FOR TREE TRANSPLANTATION IN DELHI.

Technical eligibility criteria:-

The Applicant Agency participating in this empanelment must have successfully completed any of the following in last 03 (Three) years, ending last day of month previous to the one in which tender is invited:-

- a) The Applicant Agency who will be responsible for taking up the whole tree transplantation process should have an experience of transplantation of more than 500 trees which are of three or more different plant species.
- b) Among those 500 trees, the girth of atleast 50% trees should be more than 150 cm and age class should be more than 10 years.
- c) The Applicant Agency should have atleast 3 years of experience in transplantation of native trees of semi-arid areas with video or photographs of transplantation of trees as proof of experience.
- d) Proof of adapting scientifically proven tree transplantation technology and its suitability of trees in semi-arid areas.
- e) The Applicant agency must have at least one Soil analyst or an Arboriculturalist.
- f) The Applicant agency shall submit Certificates of proof, of the above mentioned works.

Financial eligibility criteria:-

The empanelled agency participating in financial bids in the future should have:-

- Received total contractual payments in the previous three financial years and the current financial year upto the date of opening of tender of at least ₹ 50 lakhs.
- The empanelled agency shall submit Certificates to this effect which may be an attested Certificate from the concerned department /client and/or Audited Balance Sheet duly certified by the Chartered Accountant etc.

Other Conditions:-

1. The validity of this empanelment, subject to periodic review shall be valid for two years w.e.f. date of registration.
2. The performance of Empanelled Agency shall be regularly evaluated in consultation with User agencies or as and when deemed necessary. If the empanelled agencies are found engaged in unethical or not practicing Tree Transplantation in accordance with the Transplantation Policy 2020, they may be delisted from the empanelled list.

The purpose of this Transplanting Specification is to ensure the contractor adheres to the best practices during the transplantation of the existing planting material from the areas as indicated by Department's Representative.
