<u>Subject:</u> - Instructions to Candidates for Physical Standard Test/ Physical Endurance Test/Biometric Verification/Document Verification on 8 Aug, 2022 for the Post of Forest Guard-reg.

- 1. Candidates are required to report at the venue i.e. National Zoological Park (Delhi Zoo), Mathura Road, New Delhi-110003 before 04:00 AM sharply as per their scheduled mentioned in admit card. It is expected that candidates strictly adhere to time as entry into the venue will not be allowed beyond 4:30 AM. Candidates should report atleast 15 minutes before the Reporting time.
- 2. The candidate should sign a **self-declaration**, as per format at **Annexure-I** in front of the Evaluation Board.
- 3. **Items permitted into the venue for candidates:**Candidates will be permitted to carry only certain items with them into the venue.
 - a. Mask (WEARING A MASK IS COMPULSORY)
 - b. Gloves
 - c. Personal hand sanitizer
 - d. A simple ball pen.
 - e. Original Copy and self-attested photocopy of related documents (Admit Card for the physical test, photocopy of the photo ID card stapled with it andcorresponding ID card in Original with (04) four self-attested photographs.) The name on the ID and on the Admit Card should be exactly the same.
 - f. No other items are permitted inside the venue.
- 4. Candidates are advised not to bring any valuable items, bag etc. to the venue. Department shall not be responsible for the safe custody of any personal belonging of the candidates.
- 5. Candidate should maintain safe social distance with one another.

- 6. Candidate should stand in the row as per the instructions provided at venue.
- 7. All candidates will be checked with Thermo guns at the entry point for temperature. In case, any person is observed to be having above normal temperature (>99.14° F) or displaying any symptoms of the Corona virus, they will not be allowed entry into the venue.
- 8. Candidate registration/Verification: Candidate's registration will be done through photo capture and/or biometric verification at the venue. Photo captured will be matched with the photo uploaded by the respective candidate in the application. The candidate must NOT change his/her appearance from the photo uploaded by him/her at the time of filling up of application form.
- 9. **Precautions during walking:** Candidates are advised to follow COVID safety protocol during walking and not get close to other candidates. Social Distancing shall be strictly followed.
- 10. Appeal:- In case any candidate appearing for Physical Standard Test/Physical Endurance Test for the aforesaid post, is not satisfied with the decision of the Evaluation Board then he/she may file appeal to the Appellate Authority i.e. Principal Chief Conservator of Forest, Department of Forests and Wildlife, Govt. of NCT of Delhi on the same date of the event and appeal will be heard on the same day at 4:00 PM. The decision of the appellate authority shall be final.
