- c. Certificate/Marks-sheet of Secondary School Exam in which date of birth of the candidate is indicated.
- d. Degree & Certificates of all educational and professional/higher qualification, along with marks-sheet of all years/semesters, if any.
- e. Certificate/proof of SC/ST/OBC/OBC(NCL)/Ex-servicemen/EWS etc., as the case may be, issued by the concerned Competent Authority.(if applicable).
- f. Candidates already employed with Govt. Departments/PSU/Autonomous Bodies will have to produce 'No Objection Certificate(NOC)' from the employer at the time of Joining Service, if offered appointment.
