



SUPPLEMENTARY LIST-2 FOR THE POST OF FOREST GUARD


1. Department of Forests & Wildlife, Vide its Direct Recruitment Notice dated 27.12.2019 with closing date 16.02.2020 had advertised 211 vacancies (UR-88, OBC-57, SC-30, ST-15, EWS-21) for the post of Forest Guard in Department of Forests & Wildlife, Govt. of NCT of Delhi.
2. The Department of Forests and Wildlife, Govt. of NCT of Delhi vide result Notice no. F.No 1(39)/DCF(HQ)/Estt./Rect.-EdCIL/2019/12554-61 dated 28.03.2022 has provisionally shortlisted 253 candidates respectively for the post of Forest Guard on the basis on online examination held on 1-7 March, 2021, Physical Standard Test/Physical Measurement Test/Biometric Verification was conducted on 27-30 May, 2022 and document verification/Biometric Verification was held on 27-30 June, 2022.
3. Vide supplementary list for the post of Forest Guard notice dated 01.08.2022, based on the performance of the Computer Based Test of 146(OBC-94, SC-06, EWS-06, ST-14, Ex-s-26) new candidates were shortlisted to appear in Physical Endurance Test, Physical Standard Test, Biometric Verification & Document Verification subject to correctness of the information furnished by the candidates in their online application forms.
4. In continuation of result notice dated 28.03.2022 of 253 candidates and continuation of supplementary list of 146 Candidates, Supplementary list -2, based on the performance of the Computer Based Test, new 72 OBC candidates, who obtained marks above or equal to cut off marks in their respective categories, have been provisionally shortlisted to appear in Physical Endurance Test, Physical Standard Test, Biometric Verification & Document Verification subject to correctness of the information furnished by the candidates in their online application forms.



5. The supplementary shortlisted list-2 candidates for the Physical Endurance Test/Physical Standard Test/Biometric Verification/Document Verification, who have appeared in Computer Based Test is contained at **Annexure-1**.
6. 08 Candidates, who did not appear in PST/PET/Biometric Verification held on 8 AUG, 2022 due to their SSC-CGL mains examination, they had requested to reschedule their date of PST/PET/Biometric Verification. Competent Authority has considered their request and given opportunity for the same. The list of 08 candidates who PST/PET/Biometric Verification/Document Verification rescheduled is contained at **Annexure-2**. **The above said 08 candidates may appear in the PST/PET/Biometric Verification & Document Verification scheduled on 22.08.2022 based on their admit cards were generated for the PST/PET/Biometric Verification & Document Verification on 08.08.2022.**
7. Only those candidates have been considered in OBC Category who have declared that they are OBC (Delhi) in their online application form.
8. Further, since documents have not been called from the candidates along with the online application forms, as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates provisionally shortlisted for appearing the Physical Test and Physical Standard Test does not entitle them any right over the post.
9. The above short-listing for Physical Endurance Test and Physical Standard Test for the post of Forest Guard in the Department of Forests & Wildlife, Govt. of NCT of Delhi will be subject to outcome of pending court case, if any.
10. All candidates must come with original copy and one self-attested photocopy of following documents:-
 - a. Aadhar Card
 - b. Passport/Driving License/Other Government issued identification documents.
 - c. 10th Certificate and all certificates till highest qualification.
 - d. Certificates for claim of their respective categories (EWS, OBC, SC, ST, Ex-Servicemen).
 - e. 4 passport size photograph.



11. While every care has been taken in preparing the result, Department reserves the right to rectify errors and omissions, if any detected at any stage.
12. The Physical Endurance Test and Physical Standard Test shall be held on 22/08/2022 at the office of DCF South Division, near Karni Singh Shooting Range, Tughlaqabad, New Delhi-110044. All 80(72+8) candidates who have been shortlisted for PET/PST/Biometric Verification & Document Verification have to report at 7:00 AM sharp.


