The bidder should have the experience of completion of similar supply in any of the departments/autonomous institution/Universities/Hospitals/Public Sector undertaking of the Govt. of India or Govt. of NCT of Delhi or any other state Government or Local Bodies/Municipal Corporation as follows: -

Important Instruction to bidder before submission of tender:-

All the bidders are advised to submit the quotation for supply of fruits and vegetables as per attached list on APMC rate of Modal-B quality which shall indicate the percentage of overheads such as transportation, loading & unloading charges and contractor's profit over and above APMC rates, including all taxes and liabilities.

The bidder who submits the quotation for selected items will not be considered as fruits and vegetables will be procured from one firm who are qualified under Technical Bid and then falls L-1 during price evaluation.

Total quantity to be supplied each day will be 2500 kgs and may increase/decrease by the competent authority as per the daily requirement based on the number of monkeys inside the sanctuary.

The supply will be 'FOR Asola Range Office' and rates may be quoted including transportation, loading, unloading from Sabzi Mandi/ point of procurement to Asola Range Office by truck and time required for weighing of supplied fruits and vegetables at Asola Range Office and then delivering requisite quantities at 14 Monkey Feeding Points spread over Asola and Bhatti.

IX. Supply

 The successful bidder shall be asked to supply 2500 Kgs of seasonal fruits and vegetables every day between 9 AM and 11 AM at Asola Range Office where it will be weighed in front of a Committee constituted for the purpose and recorded by them in the FEED REGISTER" with dated signatures and also checked for quality.

- 2. The contractor shall record the name of seasonal fruits and vegetables brought by him with quantity of each on a numbered and dated challan in quadruplicate.
- The original and duplicate shall be submitted to the Committee who will return the duplicate challan to the supplier after necessary verification.
- 4. The actual measurements/ weights recorded by the committee shall be recorded by the staff of the department in the challan by striking out the earlier measurements/ weights mentioned in the challan in both original and duplicate copies and recoding the actual measurements as recorded by the committee in the register.
- 5. The supplier shall submit his monthly bill and APMC daily bulletin rates duly verified along with duplicate corrected challan as per these recorded measurements/ weights through concerned DRO for releasing the payments. The department shall make every effort to release the payment to the supplier within one (1) month from the date of receipt of bills by DRO through ECS/RTGS.
- The contract is initially for one year and can be extended to further one year subject to successful compliance of supply order on the same terms and conditions.
- The supplier or his work force shall not carry fire arm inside the sanctuary and will not tease or harass any animals inside the sanctuary and such episode may lead to cancellation of contract.

X. General Terms and Conditions

- The e-tenders for supply of fixed quantity of seasonal fruits and vegetables each day
 of the year including sat/ sun and holidays as food for the monkeys translocated to AB
 WLS at Asola Range Office under the jurisdiction of South Forest Division,
 Tughlaqabad, GNCT of Delhi are invited online.
- The bidder shall submit on or before the date given in the Notice inviting e-tender, the Technical Bid and the Financial Bid online in the prescribed format given in etendering.
- 3. The estimated cost of e-tender is Rs. 1.5 Crore (One Crore and Fifty Lakhs only)
- 4. Bidder shall quote the rates in the prescribed form for Price Bid given in E-tendering site against this tender on a 'single responsibility basis' so that the tender price covers contractor's all obligations and liabilities and exclusive of all taxes and shall be shown separately, if applicable.
- 5. Bidder shall quote the rates in the prescribed form for Price Bid inclusive of all seen/ unforeseen charges like transportation by truck from Mandi/ place of procurement to Asola Range Office, loading/ unloading of fruits and vegetables at Mandi/ weighing site at Asola Range Office, 14 monkey feeding points/ weigh bridge charges/ entry time of heavy vehicles prescribed by Delhi Traffic Police and the time required for all such activities.

- 13. The Tenderer shall abide by the provisions made under the Labor Laws and other relevant Statutes as applicable in execution of the work and shall be responsible for making good/ payment of compensation, if any, to any workmen or material during execution of the contract.

- 14. The department shall not be responsible for payment of any compensation on account of any loss sustained by the Tenderer on account of any natural calamity including accident of truck while bringing supplies or going back.
- 15. The Tenderer are advised in their own interest to visit the Asola Range Office and monkey feeding points and get familiarized of the activities on any working days before submitting the tender.
- The successful bidder shall submit details of workmen with I.D. proof/ vehicle registration number deployed for supply to DRO. AB WLS.
- 17. Ideally, the Tenderer is required to engage the same truck and same set of workmen, as far as possible, during the entire contact period so that they themselves and monkeys become habituated to each other, develop a fondness and can understand little gestures towards each other.
- 18. The performance in supply of seasonal fruits and vegetables will be subjected to social auditing and periodic monitoring by internal/external agencies.
- 19. Participation in the online bid shall amount to bidders' acceptance of these terms and conditions of the tender by the bidder.
- 20. No correspondence shall be entertained after opening of the Tenders.
