
**TERMS & CONDITIONS OF THE NIQ**

1. Submission of quotation shall amount to bidder's acceptance of the terms and conditions of the tender by the bidder.
2. Mode of payment would be subject to satisfactory completion of work/supply and its verifications.
3. Bidder shall quote the rates against this NIQ on a 'single responsibility' ("rate/Cost of item/Work + GST as applicable") so that the quotation price covers contractor" all obligations and liabilities. The rates and prices quoted by the Bidder shall be inclusive of all charges/Taxes. The rate quoted shall be responsive and the same should be inclusive of all statutory obligations.
4. The bidder should be from NCR and should be registered with/Trade & Taxes Department, Govt. of NCT of Delhi and should quote their GST Registration No, allotted by the Department of Trade & Taxes, Govt. of NCT of Delhi, and PAN no, allotted by the Tax Department, Govt. of India.
5. The DY. Conservator of Forests (HQ) reserves the right to accept and reject any or cancel any or all the tenders/quotations without assigning any reasons therefore.
6. The rates quoted by the firm/agency shall remain valid for the entire period of current Financial Year i.e. upto 31.03.2023 for the subject work and the Department shall not be responsible for payment of any extra of escalation of costs during the said period.

10. All disputes arising out of the execution of the agreement shall be subject to the jurisdiction of the Court at Delhi.


